# **Selectmen's Meeting Minutes**

# July 11, 2016

7:00 pm Meeting called to order by Board Chair, Jack Esposito. Also in attendance were Selectmen Jim Whipple and John Quinlan.

Dick DesRoches came before the Board to discuss the purchase of new shutters for the front of the McCollom Building. He found a company out of Illinois that offers free shipping and is less expensive than Milford Lumber. Quinlan motioned, seconded by Whipple, to purchase seven exterior shutters in the amount of \$3,378.24 for the front of the building. All in favor. DesRoches explained that in the process of siding the building, Knowlton has found a few problems with the flashing, the blocks behind the water table and the columns. Estimating up to \$1,100.00 in repairs. Eversource needs to come and disconnect power to the building. The cost of this is \$250.00 . The Board agreed that these issues need to be resolved and authorized DesRoches to move forward.

Bill McKinney requested that the Board appoint William Johnson to the Mont Vernon Planning Board as an active board member. Whipple motioned, seconded by Quinlan to appoint William Johnson to the Planning Board. All in favor.

7:10 pm Board reviewed and signed checks and the manifest.

The owner of 8 North Main Street came in to discuss complaints made about safety issues due to debris on his property. He asked for some time to get the property cleaned up. Esposito agreed to give him 60 days to clean the debris and put up a temporary fence to keep people out.
