7:00 PM - Old Mill Estates

McKinney called the meeting to order and asked everyone to stand for the Pledge of Allegiance. The review of Old Mill Estates was tabled as the documents are still with Town Council.

7:05 PM - Orchard Hill

The Board received the legal review on Orchard Hill from Town Council. There are some revisions needed on the Conservation Easement. There is a Subdivision Development Agreement that needs to be added to the documents for signature. The road bond has not yet been received. It has been made clear to that no road construction of any sort can happen until we are in receipt of the road bond. **McKinney** suggested that the Board take time to review the legal documents prior to the next meeting. There were two members of the Purgatory Fish & Game Club present interested in an update on the development. Jim Kempf, President, noted that Mr. Vaughn put so many restrictions on providing a buffer that they had to stop negotiations. They are currently raising the berm and working to make the gun club as safe as possible.

7:20 PM - Driveway Regulations

McKinney went over the recommended revisions to the driveway regulations regarding continuance, limitations on maximum slopes, and culverts. **Quinlan** questioned who would be measuring the grade of a driveway; who will be responsible for verifying the grade of a driveway. **Johnson** suggested that when the civil engineer comes out to sign off and validate an as-built, it should encompass the driveway as well as the septic. **McKinney** noted that as this would be in addition to our development regulations, he believes we would need to have a public hearing. We will aim to have the hearing on our December 12th meeting.
