Meeting Date: January 9, 2019

Meeting brought to order: 7:30 pm @ MV Town Hall Office

7:30-7:45 December meeting minutes reviewed. Adrienne made a motion to accept minutes, Joanne seconded, passed unanimously.

Correspondence: Received a request from Zach G. for clarification re. NH Stonewall Regulations. Joanne responded.

7-45-8:15: Jay reported on the current status of Carleton Pond and details regarding the recent

flood remediation that has been completed to date. Jay further stated that there is additional work scheduled to complete the drainage project. The CC discussed the proposed lighting for the pond and the desire to have lighting that is environmentally acceptable and also that is on a timer so that there is lighting during the evening hours but will automatically turn off at a designated time. Jay concurred that there should be proper lighting and the lighting would be on a timer. Jeff questioned if there would be a separate electric meter for the aerator. Jay said that the aerator would be on a timer that could be adjusted to reflect the condition of the pond to best service the pond's health. The exact timing schedule would be determined as pond evolves. Jay said that there may be some assistance from PSNH for this environmental project. Joanne thanked Jay for all the time and energy he has donated thus far to this project. The CC concurred.

Wetland Protection Update: Bill McKinney, Planning Board Chair, responded to Conservation Commission's ordinance proposal for updating the *MV Wetlands Ordinances* and concurred with this updated Wetlands Protection Ordinance Joanne submitted. In addition, he did suggest that we consider a couple of changes/additions that he felt should be included in this new legislation. Joanne reviewed these updates with the CC and it was agreed that we would update as per this additional input from the Planning Board. *The CC will meet with the Planning Board on January 29th to review and finalize the proposed Wetlands Ordinance*.

Purgatory Trails

It was agreed that this is a project that will need to be reviewed *on site due to the engineering and material requirements that will be needed to complete this repair*. Shelley also brought to our attention some trail issues/violations further down on the Purgatory Brook that need could be investigated/addressed. She will update the CC when she has further info.

Dow Road/Cheever Lane Entrance: Joanne reminded the CC that the Cheever Lane entrance to the

Purgatory Brook trails needs some signage.
